Dear Parishioner,

Your privacy is important to us, and we want to communicate with church members in a way which has their consent, and which is in line with new European Law on Data Protection. As a result of a change in Data Protection Regulation, we now need YOUR consent as to how we contact you. We will not share your information with a 'third party'.

We cannot stress enough how important it is that you complete and return the form below as soon as possible.

Please fill in the contact details you want us to use to communicate with you.

You can grant consent to all the purposes; one of the purposes or none of the purposes.

We suggest if you wish us to contact you by the means we have done so up until now, that you tick all the boxes.

Where you do not grant consent, we will not be able to use your personal data;

So, for example we may not be able to let you know about forthcoming services and events, or issue you with the Parish Magazine or other regular mailings; except in certain limited situations, such as where required to do so by law or to protect members of the public from serious harm.

You can find out more about how we use your data from our "Data Privacy Notice" which is available from our website: mullavilly.armagh.anglican.org or from the Parish Office.

You can withdraw or change your consent at any time by contacting The Honorary Secretary of the Select Vestry in writing. **Please note that all processing of your personal data will cease once you have withdrawn or do not give your consent, other than where this is required by law, but this will not affect any personal data that has already been processed prior to this point.**

In theory, this will mean that your name and contact details will be withdrawn from our Parish List and we will hold no record of you. Therefore, it is of vital importance, if you wish to be added or remain on our List/s, that this form is signed and returned by all who are over 13 years of age.

If you require more forms please contact us, or ask one of the Church Wardens at church.

It is also important that if someone in your household turns 13 and wishes to still be contacted by our Parish, that we have a signed form from them after their 13th birthday. Parents can sign for their children under the age of 13.
